

**Village Inn® presents the ‘November 2018 eClub Sign-up’
Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.
VOID WHERE PROHIBITED.**

1. Eligibility: The Village Inn® ‘National Breakfast Month’ Sweepstakes: (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age or older at the time of entry. Void where prohibited by law. Current eClub member status does not impact your odds of winning.

All online entries must be received by Wednesday, November 21, 2018 at 11:59 p.m. MST. Limit one (1) entry per person. Multiple entries by any single entrant, under varying identities or via different email addresses, or submission of an entrant that is not a real and natural person will disqualify all entries for that entrant. Entrants assume all risk of late, misdirected, incomplete, or incorrect or mistaken entries. In case of dispute, the authorized account subscriber of the email account used to enter the Sweepstakes at

the actual time of entry will be deemed the participant, and must comply with these Official Rules. The authorized account subscriber is deemed to be the natural person who is assigned an email address by an ISP, online service provider, or other organization, which is responsible for assigning email addresses.
